7/27/2022: Reviewed and discussed page 1 of NDPHA Constitution and By-laws. Changes were made to following items.

- A. Article III- Membership
 - 1. The number of classes to reflect the updated version
 - 2. "Active" was changed to "Individual" to reflect the Wild Apricot System title of the memberships.
 - 3. Life Member changed "paid-up" to "individual", (left with everyone reaching other organization's definition for "Life Member".
 - 4. Organizational Member- change wording for clarity.

Assignment for next meeting on August 24th at 9 a.m.

- 1. Research other organization for "Life Members" and what the language they use to see if we can enhance NDPHA.
- 2. Review page 2 and bring discussion points.

Reviewed and discussed page 2 of NDPHA Constitution and By-Laws. Changes were made to following items.

Article V-Governing Council

- 1. Section 1: replaced representative with "chair(s), decided to keep two members-atlarge to assist with task because of no Executive Director.
- 2. Section 6: add in filling vacancies this is where we left off at.

Article – Affiliate Representation

1. Section 1: Use the language from Historian for the ARGC except for three year term. Kept the APHA membership requirement. To keep the language consistent.

Will send out a Doodle Poll for the next meeting before NDPHA Governing Council Meeting in December.

November 22, 2022 – Sarah, Kylie and Sue attended. Reviewed and discussed NDPHA Constitution and By-laws. Changes were made as follows.

Constitution

- 1. Article III- Membership Section 7: was added about voting rights.
- 2. Article IV Officers Section 4: Updated the language for clarification. Added in the language about the President-Elect vacancy.
- 3. Article V- Governing Council Section 6: added language on to address vacancy.

By-laws

- 1. Article IV Committees Section 6: change the word "sections" to "committee" to accurately reflect the information. Removed the work plan, goals and objectives because committees have set tasks.
- 2. Article VI- Section 4 Change the language from Governing Council to general membership by a majority vote at Annual meeting.

December 12, 2022 - Sarah, Kylie and Sue attended. Reviewed and discussed NDPHA Constitution and By-laws. Changes were made as follows.

Constitution

- 1. Sarah will contact Lindsey, APHA about is it a requirement to have a Constitution and By-Laws.
- 2. Add in comment about the reason for governmental agencies will not have a "Organizational Member" because of voting power and membership benefits/dues.
- 3. Article X- Removals and Resignations there was discussion about if there was need to revoke an individual membership how would that be done. Sarah will do some research.

By-laws

- 1. Article VII Elections Section 3. Orientation was removed and comment indicating that it should be done in the Roles and Responsibilities document and prior position chair.
- 2. Article VIII- Newsletter was removed because this has not been done for several years and does not need to be in the By-Laws.
- 3. Article IX- Amendment of By-Laws was moved to Article VIII
- 4. Article X was changed to Article IX and changed from Executive Director to "Association Staff". To be more general.

Notified that we can combine the Constitution into the By Laws as one document. The document was updated and titled "2023 Proposed Bylaws".

January 23, 2023 – Sue will present the combine Constitution with By Laws for NDPHA to Governing Council for review. It was approved to send to NDPHA General Membership before Annual Meeting on June 14th, 2023.
